UNAUDITED OPERATING STATISTICS FOR THE ELEVEN MONTHS ENDED 30 NOVEMBER 2016

The board (the “Board”) of directors (the “Director(s)”) of Modern Land (China) Co., Limited (the “Company”, together with its subsidiaries, the “Group”) is pleased to announce the Group’s unaudited operating statistics for the eleven months ended 30 November 2016 as follows:

- For the eleven months ended 30 November 2016, contracted sales of the Group amounted to approximately RMB14,503.8 million, of which, contracted sales of properties amounted to approximately RMB14,297.63 million, whereas contracted sales of car parking spaces amounted to approximately RMB206.17 million. Gross floor area (“GFA”) sold for properties was approximately 1,285,556 square metres (“sq.m.”), with an average selling price of approximately RMB11,122 per sq.m..
- In November 2016, contracted sales of the Group amounted to approximately RMB998.82 million, of which, contracted sales of properties amounted to approximately RMB975.69 million, whereas contracted sales of car parking spaces amounted to approximately RMB23.13 million. GFA sold for properties was approximately 100,496 sq.m., with an average selling price of approximately RMB9,709 per sq.m..

The above-mentioned operating statistics are unaudited and are based on preliminary internal information of the Group, which may differ from the figures to be disclosed in the audited or unaudited consolidated financial statements to be published by the Company on an annual or half yearly basis due to various uncertainties during the process of collecting such sales statistics. As such, the above statistics are provided for investors’ reference only, and do not constitute, nor should they be construed as, an invitation or solicitation to sell or purchase any securities or financial products of the Company.
